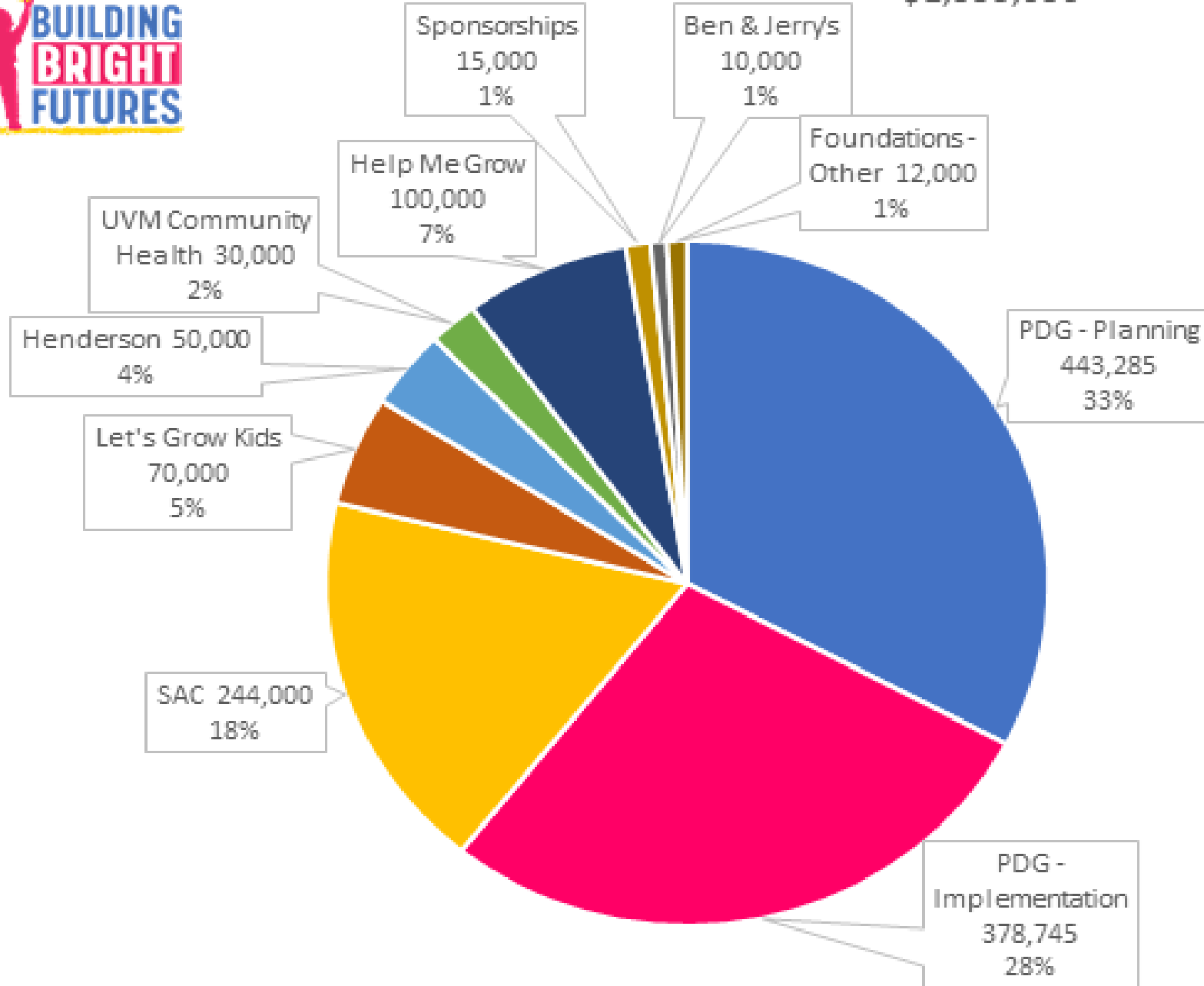
## Strategies Represented in the FY20 Budget -continued

5. Collaborate with partners and funders to sustain programs and personnel to minimize disruption while transitioning to new funding opportunities.

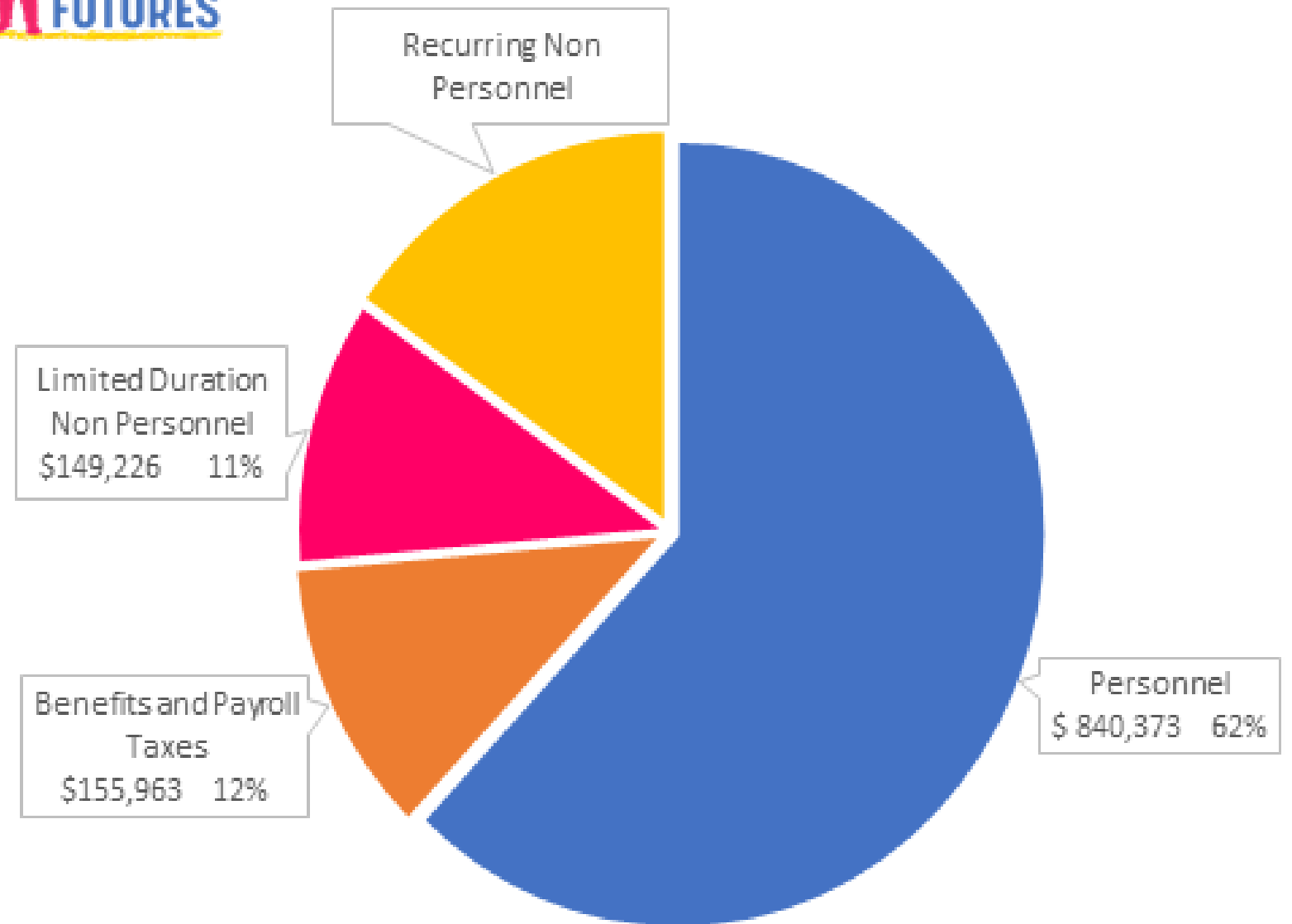
# FY20 Budget: Revenue and Expenditures

# Early Childhood and Family Mental Health: Task Force Proposal

- Bring together people across disciplines on a state level to identify and affirm vision statements that speak to an integrated system of care. Use this vision statement to develop common language and a visual continuum that will lead early childhood and mental health partners;

- review positive mental health frameworks in use across Vermont;
- identify policy recommendations to reach this shared vision.
