## **OUR MISSION & ROLE**

The mission of Building Bright Futures (BBF) is to improve the well-being of each and every child and family in Vermont by using evidence to inform policy and bringing voices together to discuss critical challenges and problem-solve.

- We bring together a robust network of policymakers, early childhood professionals, educators, health and mental health providers, business leaders, families, and other stakeholders to share insights and problem-solve through regular meetings of **12 Regional Councils**, **7 Committees moving forward the work of Vermont's Early Childhood Action Plan** (VECAP), and a **23-member State Advisory Council**.
- We empower and elevate family and community voices as partners in decision-making.
- We oversee **Vermont's Early Childhood Action Plan** (VECAP), a fiveyear strategic plan that takes a collaborative approach to building a comprehensive and integrated early childhood system that promotes healthy child development and family stability.

We centralize and disseminate early childhood data to inform policy through Vermont's Early Childhood Data and Policy Center at **VermontKidsData.org**, a free, centralized clearinghouse of data, publications, and policy recommendations on the well-being of Vermont children through age 8. We also produce a yearly report called **The State of Vermont's Children**, an objective, data-driven assessment of the state of young child and family well-being in Vermont; progress on selected indicators and outcomes for the early care, health, and education system; and recommendations on how best to improve child and family well-being.

### **OUR IMPACT**

BBF utilizes a robust, 450+ person network to convene stakeholders to problem-solve, empower families and communities, monitor outcomes for children and families, respond to gaps, and advise decision-makers. Below we have outlined a few highlights from the last year across our primary functions: to **advise, monitor, convene, respond, and empower**.

### Advise

One of the most critical roles the Building Bright Futures State Advisory Council Network has is serving as the primary advisor to Vermont's Governor and Legislature on the well-being of children in the prenatal period through age 8 and their families. The <u>2021-2022 Policy Recommendations of</u> <u>Vermont's Early Childhood State Advisory Council Network</u>, developed based on input from across the BBF Network, were formally endorsed by the 23-member Governor-appointed State Advisory Council, elevating a series of recommendations targeting the most pressing challenges in the system.

Additionally, **BBF provided formal advisement 36 times** (in multiple forms) to Vermont's General Assembly, the Governor's Office and Administration, or the state's Federal Delegation. More important than the number of advisement opportunities are the trusted relationships built between the Building Bright Futures team and members of the General Assembly, Governor's Office and Administration, and Federal Delegation, enabling change and action within the state's early childhood system by calling attention to challenges, errors, or emerging issues. <u>Building Bright Futures Network Advisement</u> can be found at Vermont's Early Childhood Data and Policy Center.

Finally, the Legislature selected the Building Bright Futures State Advisory Council to oversee the **Child Care and Early Childhood Education Systems Analysis** called for under Act 45, which was a critical advisory role in FY22. Throughout this year, BBF worked closely with Foresight Law + Policy and Watershed Advisors to execute the project. BBF supported direct communication with the Governor's Office, Agency leaders, and the Legislature to help all involved parties to navigate the process and conduct internal planning in collaboration with the contractors. A final report was completed and submitted to the Legislature on July 1, 2022, and a <u>briefing was held on</u> <u>July 11</u>. The process included a 50-person cross-agency advisory committee and the engagement of over 400 early childhood stakeholders.

BBF plays a critical role in monitoring Vermont's early childhood system and has a proven track record of supporting the state in capturing, compiling, and producing highquality cross-sector data. This year, BBF and Vermont's Early Childhood Data and Policy Center produced three significant original documents, more than 80 publications, and new and updated data at Vermontkidsdata. org, Vermont's critical tool for **answering early childhood policy questions**. The three major documents were:

- 1. <u>The State of Vermont's Children: 2021</u> <u>Year in Review</u>
- 2. <u>Issue Brief: Integration in Vermont's Early</u> <u>Childhood System</u>
- 3. <u>Data Brief: Exclusionary Discipline in</u> <u>Vermont: Early Childhood</u>



### Convene

In 2022, BBF hosted the annual Vermont Early Childhood Action Plan (VECAP) Summit, with 70 people from across the network focused on monitoring the VECAP. Participants engaged in small groups to share progress toward the VECAP goals and discussed emerging needs and priorities for the coming year. Some of the key priorities that emerged from this discussion and through the VECAP Committees include: early childhood workforce across sectors, housing, care coordination, quality in child care and early childhood education, mental health, partnership with families, and ensuring Vermont develops a strong process to guide early childhood governance transitions. Participants reflected that this process felt meaningful as a way to better understand the vision and the steps to get there.


Building Bright Futures' 12 Regional Councils serve as the early childhood experts within their communities, identifying local needs and driving decision-making about how best to meet those needs. In 2021, BBF established the Vermont Early Childhood Fund, awarding \$100,000 of private funds to help address barriers in the system and make impactful connections with Regional Councils. Projects were selected to address emerging community needs through regional creative solutions, including anti-racism training for early childhood educators in Chittenden County, meeting family transportation needs through gas cards and auto repairs in Franklin/Grand Isle, and purchasing vision and screening equipment for the Bennington Children's Integrated Services Early Intervention Program.

BBF serves as a key liaison between those most impacted by early childhood policy decisions (children, families, communities, providers) and decision-makers. BBF believes that representation and voice matter, and recognizes families and communities as key components to informing sound, sensible policy recommendations that improve equitable access to early childhood services. As part of BBF's efforts to expand Vermont's family partnership and leadership opportunities within the early childhood system through the VIP-3/ECCS Grant, the Families and Communities Committee has continued to convene meaningful opportunities for families to learn about the early childhood system and policies, for decision-makers to learn about the perspectives of families, and for families to be empowered to engage as partners throughout the system. This year, the committee developed and fielded a survey on the experiences of families with young children across Vermont, including an emphasis on how welcomed they feel and how accessible they found various services. The resulting data will be shared with decision-makers to inform programs and policy to better serve young children and their families.

BBF also created a **centralized tracker to collect emerging priorities and questions** from early childhood stakeholders. More than 30 emerging issues, challenges, and priorities from early childhood stakeholders throughout the BBF Network were shared with the appropriate early childhood partners and decision-makers between January and June 2022.


