## Putting policy recommendations into action

We started by reviewing BBF's 2024 Policy recommendations specific to data.

To work toward those recommendations we reviewed the D&E's rough draft vision specific to reducing inequities and data collection and reporting.

Vision: over the last year of our convening we have heard that generally this group is aiming to work to make sure that data are

- meaningful,
- accessible,
- high-quality, and
- involve impacted individuals and communities
- Completing the data cycle with reporting
- Well funded

Additional details and important elements of this vision were developed in the first frame of this <u>Jamboard</u>.

We hope to find a time over the summer to convene for a full or half day retreat to create an aligned strategic plan that includes more of the important details that arose today. More to come on that.

**Desired outcome for this meeting**: Walk away from this meeting having identified some specific scopes of work that are items that can be moved forward in the coming year.

This group took time to identify meaningful projects and themes that could be worked on collectively over the next 6-12 months and those ideas can be found in frame two of the <u>Jamboard</u>.

  - Making progress with CCWIS -
    - have some money,
    - RFP feds have reviewed and need to review once more then AHS review, likely to publish in late January
  - Carlie presented to \_\_\_\_\_ which will be distributed in early January
  - o Long term goal to make connections with other VT systems
  - High-end system of care
    - 5 children are being staffed 2:1 or 3:1 -
    - Staff are burnt out
  - OCYF annual report will include a long section on CCWIS
- CDD
  - Working to get the workforce reports out (CIS, HS, and Child Care)
  - Hired a communications person, hired a PDG data person, hired another data team member
  - Continuing to work on CDDIS improvements
  - Act 76 work
  - o CIS
- ARPA funding is at a close talking about how to share the difference that was made - what was done and the impact it made
- Partnering with BBF on sharing Special Accommodation Grant information and potentially reporting Early Intervention Family Survey data
- BBF

  - o \$1.2 million in VECF grants

  - o State of Working Vermonters will be released in mid-January
  - Who pays Vermont will also be released in mid-January
- Reach-Up



- Submitting annual report to the legislature which will be posted on the public website:
- This year and last year charts and tables are all posted on the website with links to the report with highlights
- o Ratable reduction report will be released in mid-March
  - Calculation for Reach Up benefits took the basic needs plus the housing allowance X .49
  - Feds have not increased the block grant
  - State has only increased the basic needs only twice during the past 25 years, but has never increased the housing allowance
